CONSULTATION STATEMENT (Revised May and August 2023) Community Engagement on the modification of Brixton Parish Neighbourhood Plan 2014- 2034

In accordance with Regulation 14 of Neighbourhood Planning (General) Regulations 2012, Brixton Parish Council consulted on the modification proposal from 12.00 on Monday 12th December 2022 to 12.00 on the 22nd of January 2023. The revised map and the modification were posted on the Brixton Parish Council website and paper copies were available in the Post Office in Brixton Village. Posters advertising the consultation were placed on the two village notice boards, in the Community Room, and in the 'The Foxhound' (the local pub). The consultation was also advertised on the Brixton Village Facebook page which has just over 1,700 members, and in the 'Brixton Magazine' which is delivered to approximately 400 households across the community.

Two responses were received as a result of the consultation and were noted at the meeting of Brixton Parish Council on the 25^{th of} January 2023

Basic Conditions Statement

The modification meets the basic conditions statement in the original Brixton Parish Neighbourhood Plan 2014-2034. It continues to meet the vision and objectives 'to conserve and enhance the rural and historic environment of Brixton, retain the identity and independent character of Brixton village and surrounding hamlets and to nurture thriving communities across the parish by providing facilities and taking opportunities to meet the needs and wishes of the community'.

Strategic Environmental Assessment and Habitats Regulations Assessment

The modification meets the Strategic Assessment and Habitats Regulations Assessment completed for the original Brixton Parish Neighborhood Plan 2014 -2034. A further assessment is not required as the modification clarifies the area and there are no changes to the Plan.

Conclusion

Having considered the representations, the Qualifying Body (Brixton Parish Council) concluded that the concerns expressed did not warrant making a change to the proposed extension of the Brixton Open Gap and therefore that the modification should be made as originally proposed.
